Regular Agenda

1. Call to Order

Meeting was called to order by Chair Saxton at 8:30 a.m. A quorum was present.

2. Pledge of Allegiance

Saxton led the Board of Supervisors in the Pledge of Allegiance.

3. Open Forum/Introductions

There were no comments from the audience.

4. Approval of Agenda

20.101 - Motion by Nelson, second by Goenner to approve the agenda with submitted addition. All members voting yes. Motion carried.

5. Secretary's Report -- September 10, 2020 Board Meeting Minutes

20.102 - Motion by Goenner, second by Nelson to approve the September 10, 2020 Board Meeting Minutes as presented. All members voting yes. Motion carried.

6. Treasurer's Report – September 2020 Financial Reports

Selvog read the September 2020 Program Summary Report. Discussion was had.

- 20.103 Motion by Nelson, second by Goenner to accept the September 2020 Financial Reports • as submitted, subject to audit. All members voting yes. Motion carried.
- 7. Treasurer's Report October 2020 Accounts Payable Selvog reviewed the October 2020 Accounts Payable Summary. The report includes all unpaid bills from 9/10/2020 – 10/7/2020. Check numbers 7056 through 7072 totaling \$27,096.13 were submitted for approval. Discussion was had.
 - 20.104 Motion by Goenner, second by Nelson to approve the September 2020 Accounts Payable as submitted. All members voting yes. Motion carried.
- 8. Supervisor Committee Reports & Vouchers Saxton reported attendance at the Rum River 1W1P Policy Meeting, Binsfeld reported attendance at the Elk River Clean Up event. No committee report from Nelson, Goenner, and Selvog.
 - **20.105** Motion by Goenner, second by Selvog to approve the Supervisor Vouchers as submitted. All members voting yes. Motion carried.

- 9. District Manager's Report -- Larson reviewed her written report; providing an update on a well sealing project as well as an update on the QuickBase Software program. Discussion was had.
- **10.** NRCS Activity Report Chris Hogge, NRCS District Conservationist reviewed his written report; providing an update on NRCS programs and technical assistance. Discussion was had.
- **11. District Staff Monthly Reports -** Available SWCD staff reviewed their monthly activities with the Board. Individual written reports available upon request.
- 12. Authorization to Provide Final Payment to Lake Orono for AIS Control Grant AIS-FY20-05 for \$500.00 Larson reviewed the project with the Board. The original grant with Lake Orono for treatment of aquatic invasive species was approved on March 23, 2020. The total grant awarded was for \$2,000.00; 75% (\$1,500.00) was distributed following approval of original contract. Project has been completed and deliverables have been met, Larson requested the final 25% (\$500.00) payment. Funding for this project will be allocated from FY20 AIS Grants.
 - **20.106** Motion by Nelson, second by Binsfeld to provide final payment to Lake Orono Improvement Association for an AIS control project, AIS-FY20-05. All members voting yes. Motion carried.

Check #7073 for \$500.00 was signed during the meeting.

- 13. Authorization to Provide Final Payment to Lake Orono for AIS Management AIS-FY20-01 for \$525.00 Larson reviewed the project with the Board. The original grant with Lake Orono for point-intercept surveys for a lake vegetation management plan was approved on March 23, 2020. The total grant awarded was for \$2,800.00; 75% (\$1,575.00) was distributed following approval of original contract. Project has been completed and deliverables have been met, Larson requested the final 25% (\$525.00) payment. Funding for this project will be allocated from FY20 AIS Grants.
 - 20.107 Motion by Nelson, second by Binsfeld to provide final payment to Lake Orono Improvement Association for an AIS Management project, AIS-FY20-01. All members voting yes. Motion carried.

- **15.** Authorization to Execute 2021 Local Capacity Services and Buffer Law Implementation Program Grant Agreement with BWSR Larson reviewed the agreement with the Board noting that the Local Capacity funds remain the same as the previous year however the Buffer Implementation Grant amount was reduced by 14%. Discussion was had.
