### Regular Agenda

1. Call to Order

Meeting was called to order by Chair Nelson at 8:30 a.m. A quorum was present.

2. Pledge of Allegiance

Nelson led the Board of Supervisors in the Pledge of Allegiance.

3. Open Forum/Introductions

There were no comments from the audience.

- 4. Approval of Agenda Saxton requested time to discuss the Rum River 1W1P process discussion occurred during the Supervisor Reports.
  - 21.07.01 Motion by Goenner, second by Selvog to approve the agenda as submitted. All members voting in favor. Motion carried.
- 5. Secretary's Report June 10, 2021 Board Meeting Minutes
  - 21.07.02 Motion by Goenner, second by Binsfeld to approve the June 10, 2021 Board Meeting Minutes as presented. All members voting in favor. Motion carried.
- 6. Treasurer's Report June 2021 Financial Reports

Binsfeld read the June 2021 Program Summary Report. Discussion was had.

- 21.07.03 Motion by Binsfeld, second by Saxton to accept the June 2021 Financial Reports as submitted, subject to audit. All members voting in favor. Motion carried.
- 7. Treasurer's Report July 2021 Accounts Payable The Board reviewed the July 2021 Accounts Payable Summary. The report includes all unpaid bills from 6/10/2021 - 7/7/2021. Check numbers 7171 through 7182 totaling \$33,692.98 were submitted for approval. Discussion was had.
  - 21.07.04 Motion by Goenner, second by Binsfeld to approve the July 2021 Accounts Payable as submitted. All members voting in favor. Motion carried.
- 8. Supervisor Committee Reports & Vouchers Saxton and Goenner reported attendance at the MASWCD Area IV Summer Meeting. Selvog provided updates on the Farm Friends Barn. Saxton reported attendance at the Rum River Policy Committee Meeting as well as the Rum River TAC meeting. Saxton and Cibulka discussed the strategies and actions occurring in the implementation table of the draft plan as well as the process for staff and Policy Committee members to review the activities. Larson suggested

scheduling an upcoming staff and supervisor workshop dedicated to the Rum River 1W1P review. No Committee Reports from Nelson, and Binsfeld.

- 21.07.05 Motion by Goenner, second by Selvog to approve the Supervisor Vouchers as submitted. All members voting in favor. Motion carried.
- 9. District Manager's Report Larson reviewed her written report. Larson noted that BWSR has opened the RFP for the FY2022 CWF Grants, proposed applications will be presented at the next meeting. Larson also reported that she has reached out to the Assistant County Administrator regarding the potential use of American Rescue Plan Act (ARPA) funds for water quality projects within our county. Larson reported that she has met with TriCap to discuss future office cleaning needs. The SWCD no longer requires the cleaning services provided by Options, Inc. The previous agreement required the SWCD to furnish cleaning supplies and pay for the cost of the Waste Management Services in exchange for cleaning services. Moving forward, TriCap will split the cost of the garbage and recycling services as well as the cost of paper towels, bath tissue, and hand soap. Larson summarized the events of the previous week that included a threatening voicemail from a non-compliant buffer landowner. Discussion was had. Written report available upon request.
- 10. NRCS Activity Report Hogge, NRCS District Conservationist reviewed the NRCS activity report, providing an update on NRCS programs and technical assistance. Written report available upon request.
- **11. District Staff Monthly Reports -** Available SWCD staff reviewed their monthly activities with the Board. Individual written reports available upon request.
- 12. Authorization to amend cost share contract with J Audet for a Raingarden project, #2021-06-03, not to exceed \$2,636.84 Larson reviewed the contract with the Board. The original contract with John Audet for a raingarden project (712M) Section 24, City of Big Lake was approved in June. John requested an additional raingarden project on his property. The new estimated project cost is \$4,056.70. Larson requested approval of 65% cost share, not to exceed \$2,636.84. Funding for this project will be allocated from FY20 Capacity Structural.
  - 21.06.07 Motion by Goenner, second by Binsfeld to amend cost share contract with J Audet for a Raingarden project, #2021-06-03, not to exceed \$2,636.84. All members voting in favor. Motion carried.
- 13. Consider update to Fee Structure Uniformity Testing Larson requested the Board consider adding uniformity tests to the fee structure as presented. Wagner discussed the existing service noting that historically the District has offered this service for free by incorporating the staff time into various grant opportunities but with the recent increase in interest for Irrigation Water Management due to energy audits and VFD (variable frequency drive) the workload has increased. Staff is proposing offering the first pivot for free but operations needing multiple pivots tested could be charged for any additional pivots. Discussion was had.
  - 21.07.07 Motion by Goenner, second by Saxton to update the Fee Structure to include a service fee for additional Uniformity Tests. All members voting in favor. Motion carried.
- 14. The total project cost was \$615.00, total grant awarded was \$461.25.
