











Sherburne County AIS Prevention Aid Program: A Snapshot of Accomplishments in 2019

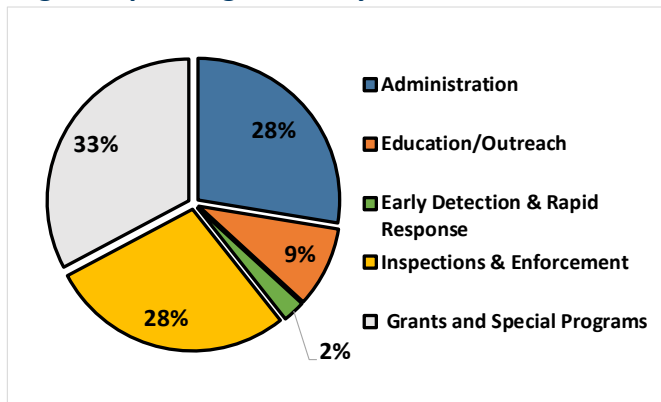
Program Summary

Now in its 5th year, the Sherburne County AIS Prevention Program strives to be an effective tool to educate the public about AIS and greatly reduce the opportunity for new infestations to be introduced to Sherburne County waters. Below is a collection of accomplishments from the 2019 program.

Program Spending Summary



The graph at left represents the categorical spending of \$69,817 dollars in 2019 for the AIS Prevention Program.

- Administrative time includes reporting and project element oversight, including implementation of other category programs
- Education and outreach expenditures are largely for supplies and a contracted theatre group.
- ED & RR expenses are for supplies to support existing programs.
- Paid inspections make up a significant portion of the budget
- The County grant program supports lake planning, AIS management, and volunteer mobilization.

Success Stories

Sherburne County continues to utilize a diverse approach to combat AIS – through both preventing the introduction of new species and supporting management of existing infestations (thus reducing their opportunity to spread elsewhere). Volunteers and the efforts of organized lake groups are an essential implementor of these programs, which include AIS Early Detection and Monitoring, Public Access Outreach, and managing existing infestations. Together, 32 volunteers completed 478.5 hours of volunteer work in 2019.

Reports and Products

This year marks the last of the Sherburne County 5-Year AIS Prevention Plan. The 2019 AIS Task Force met numerous times to examine existing programs and alternatives and provided recommendations for a new, 2020-2024 AIS Prevention Plan. This report was completed in December and will be presented to the Sherburne County Commissioners in January 2020 for approval.

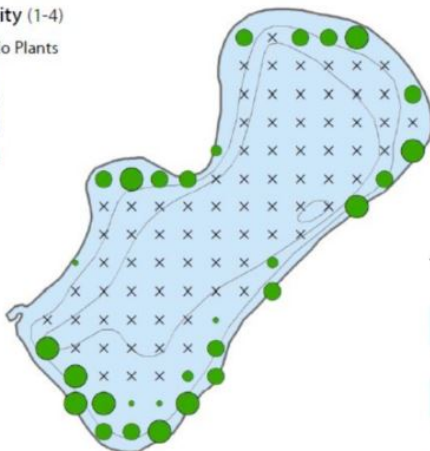
