## STATUS SUMMARY - GOAL & OBJECTIVES OBTAINED / ACTIVITES AND OUTCOMES

The goal of the project is to assist with implementation of Nitrogen Fertilizer Management Plan in areas found to have elevated levels of nitrate in drinking water in Sherburne County. To-date, two townships (Haven & Clear Lake) have been identified as exceeding the Health Risk Limit for nitrates. The SWCD has hosted one LAT meeting along with MDA and U of M Extension staff. The SWCD reserved the meeting location, 2 staff members attended the meeting, and the minutes of the meeting were taken and distributed to the LAT members. SWCD staff also attended the public hearing for the Nitrogen Rule and have met with MDA and U of MN Extension staff on how to continue moving forward including modification of the budget.

## STATUS SUMMARY - GOAL & OBJECTIVES OBTAINED / ACTIVITES AND OUTCOMES

The goal of the project is to assist with implementation of Nitrogen Fertilizer Management Plan in areas found to have elevated levels of nitrate in drinking water in Sherburne County. To-date, two townships (Haven & Clear Lake) have been identified as exceeding the Health Risk Limit for nitrates. In December, SWCD staff partnered with NRCS to send out a cover crop themed letter to provide outreach on multiple species cover crops, an AMT identified until the NFMP. SWCD staff also advertised, organized, and attended a Lunch and Learn. The focus was on Irrigation Water Management and the Economics of Cover Crops. The turnout was exceptional and it provided staff the opportunity to discuss the NFMP and Nitrogen Rule.
