7. Approve 2019 District Board Bylaws, Operating Rules and Guidelines

Larson reviewed suggested amendments to the Bylaws, Operating Rules and Guidelines. Saxton discussed numerous suggested edits to the document. Discussion was had. The document was edited during the meeting with consensus.

- **18. Supervisor Committee Reports & Vouchers –** Supervisors reviewed their meeting attendance. Discussion was had,

- **19. District Managers Report** Larson reviewed her monthly activities and provided an update on the new supervisor email system. Discussion was had. Written report available upon request.

- 22. Adopt District Erosion Control & Management Program Policy Cibulka provided an update on the proposed changes to the District's Cost Share Program. Discussion was had. A copy of the updated policy will be posted on the SSWCD website.

- 23. Authorization to Execute Agreement with MN Board of Water and Soil Resources for the FY19 Sherburne County Targeted Nitrate Reduction BMP Implementation Grant Larson stated that the workplan has been submitted and reviewed by the Board Conservationist. Discussion was had.
 - 19.016 Motion by Saxton, second by Selvog to execute FY19 CWF Grant Agreement with MN Board of Water and Soil Resources when available. All members voting yes. Motion carried.
- **23a.** Consider Elk River Watershed Association Member Per Diem increase Selvog stated that discussion was had at the December ERWA meeting regarding member per diems. At present time, the members at large receive a \$30.00 per diem plus mileage. According to the ERWA bylaws, Sherburne SWCD as fiscal agent sets the per diem rates. Selvog suggested increasing the member per diem rates to \$60 plus mileage. Discussion was had.

- **23d.** Consider submittal of FOTG Notice MN-162 to NRCS State Conservationist Larson distributed a joint letter drafted by Stearns and Sherburne SWCD staff voicing their concerns regarding removal of Eastern Red Cedar from the Conservation Tree and Shrub Group and as a recommended species under NRSCS Standard 380 Windbreak/Shelterbelt Establishment and NRCS Standard 612 Tree/Shrub Establishment. Selvog reviewed the letter in detail. Discussion was had.
 - 19.020 Motion by Goenner, second by Selvog to submit FOTG Notice MN-162 to NRCS State Conservationist. All members voting yes. Motion carried.
- 24. Upcoming Meetings and Events Discussion was had regarding upcoming events and schedules.
