#### Regular Agenda

# 1. Call to Order

Meeting was called to order by Chair Nelson at 8:30 a.m. A quorum was present.

# 2. Pledge of Allegiance

Nelson led the Board of Supervisors in the Pledge of Allegiance.

# 3. Open Forum/Introductions

There were no comments from the audience.

#### 4. Approval of Consent Agenda

#### Approval of August 12, 2021 Board Meeting Minutes

The August 12, 2021 Board Meeting Minutes were presented.

## **Acceptance of August 2021 Financial Reports**

The August 2021 Financial Reports were presented, subject to audit.

#### Approval of September 2021 Accounts Payable

The September 2021 Accounts Payable report was presented. The report includes all unpaid bills from 8/12/2021 - 9/8/202. Check numbers 7206 through 7210 totaling \$14,938.20 were submitted for approval.

Authorization to provide final payment to G Winkels for a Well Sealing project, FY21-WS-06 for \$750.00 - The original contract with Gerald Winkels for two Well Sealings was approved on May 18, 2021. The total project cost is \$1,450.00 (\$950 and \$500), and the project was approved at 50% cost share, not to exceed \$1,000.00. Funding for this project will be allocated from the FY19 Local Capacity - Structural Fund. Check #7211 for \$750.00 was signed during the meeting.

Authorization to provide final payment to A & L Peterson Farm Inc for a Multi Species Cover Crop project, #NC20-04-02 for \$1,875.00 - The original contract with Ryan and Nick Peterson for a Multi Species Cover Crop project was approved on April 8, 2021. The total project cost is \$1,875.00, and the project was approved at a flat rate, not to exceed \$1,875.00. Total cost share amount is \$1,875.00. Funding for this project will be allocated from the FY20 TNC Cargill grant. Check #7212 for \$1,875.00 was signed during the meeting.

Authorization to provide final payment to Birch Lake Association, AIS-FY21-10 for \$500.00 - The original grant with Birch Lake Association for AIS Management of Eurasian Water Milfoil was approved on March 11, 2021. The total project cost is \$6,066.06, total grant awarded was \$2,000.00. Initial 75% payment was made upon grant approval. Funding for this project will be allocated from FY21 AIS — Mini grant program. Check #7213 for \$500.00 was signed during the meeting.

**Authorization to execute JPA with the City of Princeton for Adopt a Drain Program -** The JPA signed by the Princeton Mayor and attested by the City Clerk was presented.

**Authorization to execute JPA with the Livonia Township for Adopt a Drain Program** - The JPA signed by the Township Chair and attested by the Township Clerk was presented.

Authorization to execute FY22 & FY23 SWCD Programs & Operations Grant agreement with BWSR — The agreement includes FY22 & FY23 Conservation Delivery and State Cost Share funding. Amounts awarded are the same as previous years.

Authorization to execute 2018 CWF Elk River Bacteria Reduction Grant Amendment with BWSR - The original grant expiration date was 12/31/2021, requesting acceptance of grant amendment extending the expiration date to 4/29/2022.

Authorization to execute 2019 CWF Nitrate Reduction Grant Amendment with BWSR - The original grant expiration date was 12/31/2021, requesting acceptance of grant amendment extending the expiration date to 12/31/2022.

Board consensus to move Financial Reports and Accounts Payable to regular agenda moving forward.

- 6. Supervisor Committee Reports & Vouchers Binsfeld reported attendance at the Metro Conservation District. Selvog provided an update on the planting around the Farm Friends Barn. No committee reports from Saxton, Nelson, and Goenner.
  - **21.09.03** Motion by Goenner, second by Saxton to approve the Supervisor Vouchers as submitted. All members voting in favor. Motion carried.
- 7. District Manager's Report Larson reviewed her monthly activities. Written report available upon request.
- **8. NRCS Activity Report** Hogge, NRCS District Conservationist reviewed the NRCS activity report, providing an update on NRCS programs and technical assistance. Written report available upon request.
- **9. District Staff Monthly Reports** Available SWCD staff reviewed their monthly activities with the Board. Individual written reports available upon request.

Supervisor Saxton requested Larson contact the County regarding vaccination / weekly COVID testing mandates.

- 10. Authorization to execute cost share contract with A Halbur for a Waste Storage Facility project, #ERB-FY18-06, not to exceed \$14,691.75 Larson reviewed the contract with the Board. The proposed contract is with Alan Halbur for a Waste Storage Facility (313) in Section 27, Becker Township. The estimated project cost is \$19,589.00. Requested approval of 75% cost share not to exceed \$14,691.75. Engineering for the project was done through Wright SWCD. Funding for this project will be allocated from CWF FY18 Elk River Bacteria Reduction Grant.
  - 21.09.04 Motion by Saxton, second by Selvog to execute contract with A Halbur for a Waste Storage Facility project - #ERB-FY18-06, not to exceed \$14,691.75. All members voting in favor. Motion carried.
- 11. Authorization to execute cost share contract with L Brownell for a Pollinator Planting project, #2021-09-01, not to exceed \$350.00 Larson reviewed the contract with the Board. The proposed contract is with Jessica and Leon Brownell for a Pollinator Planting (327) in Section 12, City of St. Cloud. The estimated project cost is \$733.00. Requesting approval of 75% cost share not to exceed \$350.00. Funding for this project will be allocated from SWCD Capacity Non-Structural Cost Share funds.
  - 21.09.05 Motion by Selvog, second by Binsfeld to execute contract with L Brownell for a Pollinator Planting project #2021-09-01, not to exceed \$350.00. All members voting in favor. Motion carried.
- 11a. Authorization to execute cost share contract with A Dierks for a Lawns to Legumes demonstration project, #L2L-2021-09-01, not to exceed \$270.00 Larson reviewed the contract with the Board. The proposed contract with Anna Dierks is for a Pollinator Meadow (725M) Section 32, Orrock Township. The estimated project cost is \$462.00. Requested approval of 90% cost share, not to exceed \$270.00. Funding for this project will be allocated from Lawns to Legumes High Priority.
  - 21.09.06 Motion by Goenner, second by Binsfeld to execute contract with A Dierks for a Lawns to Legumes Demonstration project #L2L-2021-09-01, not to exceed \$270.00. All members voting in favor. Motion carried.
- 12. AlS Contingency Request Eagle Lake Carp Monitoring & Biomass Estimation Cibulka reviewed the proposed project with the Board. Larson noted the current balance in the AlS Contingency Fund is \$20,464.42. The total request from the AlS Contingency fund is \$10,000. \$8,345 towards the consultant costs and \$1,655 towards SWCD staff time. Discussion was had.
  - 21.09.07 Motion by Goenner, second by Saxton to authorize the use of AIS Contingency funds as presented. All members voting in favor. Motion carried.
- 13. Authorization to execute Professional Services Agreement with WSB for Eagle Lake Carp Monitoring & Biomass Estimation, not to exceed \$9,345.00 Larson noted that the agreement was drafted by the Sherburne County Attorney and submitted to WSB for consideration. Larson requested authorization to execute the agreement once all parties have reviewed the document.
  - **21.09.08** Motion by Goenner, second by Saxton to authorize execution of Professional Service Agreement with WSB, not to exceed \$9,345.00. All members voting in favor. Motion carried.
- 13a. Authorization to submit Letter of Commitment for the Conservation Partners Legacy Grant Program

   Larson noted the District, in partnership with The City of Elk River, is submitting a Conservation

  Partners Legacy Grant Application for the Houlton property Mississippi River streambank stabilization

project. The grant application requires a Letter of Commitment identifying the match commitment of each partner.
